Sub: Pending greivences of executives.

1. Immunity from transfer to office bearers of the association.

Circle secretary had written a letter for providing immunity from transfer to our office bearers vide letter No: SNEA/ Rajasthan/Correspondence/2016-2017/27 dated 02.05.2017. Circle administration issued a letter vide letter no. STA/BSNL/112-610/SNEA/2016 dated 09.05.2017 with instruction that these cases should be forwarded from SSA head. All the cases have been received from concerned SSAs and put up for approval but case is still pending for want of recommendation from SSA head that has already been received as a forwarding letter containing remarks that "This letter is issued with the approval of SSA head". So it is further requested that these orders should be issued without any further delay to overcome the frustration among office bearers of recognized association.

2. Request transfer of JTOs who has completed three years of stay at working station.

Request transfer of JTOs who have completed four years of stay have been considered vide STA/8-15/Ch-14/R-Trf/JTO/2017/11 dated 21.04.2017. Association has requested for consideration of request transfer of JTOs who have completed three years of stay at working station. Circle administration has issued the orders for six JTOs out of thirteen leaving seven for second lot. It is requested that request transfer orders of remaining seven JTOs may be issued immediately so that disparity among consideration of request transfer of JTOs should be removed and frustration of the remaining seven JTOs may be resolved.

3. Cancellation of transfer order of Sh. O P Parashar JTO from Bhilwara to Sirohi.

Sh. O P Parashar has been transferred from Bhilwara to Sirohi vide letter No. STA/8-15/Ch-14/R-Trf/JTO/2017/11 dated 21.04.2017 on longest stay basis. Mr. Parashar met an accident on 07/07/2014. His urethra tube ruptured in this accident so he has to taken regular treatment on specialized hospital at Bhilwara and Ahemdabad. He can not survive at Sirohi so his transfer order should be cancellation on medical ground.

4. Change of posting station of Sh. Ravi Agrawal from Bharatpur to Tonk.

Sh. Ravi Agrawal has been transferred from jaipur TD to Bharatpur TD vide letter No. STA/8-15/Ch-14/R-Trf/JTO/2017/11 dated 21.04.2017 on longest stay basis. He has applied for change of posting

station at his own cost from Bharatpur to Tonk. So please arrange to change his posting orders from Bharatpur to Tonk.

5.Consideration of request transfer under rule-8 of Mr. Sanjeev Chauhan from Rajasthan to UP (East).

Mr. Sanjeev Chauhan has completed 15 years of service, 12 years as TTA and 3 years as JTO at Jaisalmer. Corporate office has issued a letter for counting the service rendered as TTS also for counting the stay period to consider the case of request transfer under rule-8 from one circle to other circle. So it is requested that his case should be forwarded to UP (East) on spouse ground. His wife is working as Govt. teacher at Sitapur (UP).

6.Retention of Mr. Shekhar Gaur, JTO Jaipur :

Mr. Shekhar Gaur is under is under transfer from Circle office Jaipur to Ajmer vide letter No. STA/8-15/ch-12/R-Trf/JTO 2015/6 dated 08-04-2015 on longest stay basis and he has been relieved from CO Jaipur vide letter No. STA/7-12/JTO/65 Dated 30-07-2016. Mr. Shekhar Gaur is divorced person and living with his 80 years old mother. His mother is suffering with chronic remehtied Arthritics and diffusion of bones disease. She is critically ill and recently admitted in hospital. Mr. Shekhar is not in a position to shift her at Ajmer and leaving alone at Jaipur. So it is requested that Mr. Shekhar Gaur should be returned at Jaipur till 31-03-2018, so that he can attend her mother at Jaipur till recovering her health.

7. Retention of Mr. Gopal Lal Bairwa, SDE Kota :

Mr. Gopal Lal Bairwa was transferred from Kota to Bundi on his request but due to his family circumstances he is unable to join at Bundi so it is requested that his transfer order may be kept held in abeyance for one year after that he will join at Bundi. His case for retention at Kota for one year is duly recommended by SSA head.

8.Request transfer case of Mr. N L Meena TDM Jaisalmer:

Request transfer case of Mr. N L Meena TDM Jaisalmer was considered on request of association vide letter no. STA/8-11/STS-DGM (Adhoc)/2017-18/11 dated 08/05/2017 before relieving Mr. N L Meena from Jaisalmer to enable him to join at Alwar his transfer order has been canceled by circle administration vide letter no. STA/8-11/STS-DGM (Adhoc)/2017-18/26 dated 03/06/2017. Mr. N L Meena has served 10 years at soft tenure station Banswara and about three years at BSNL headquarter New Delhi. He is working as TDM Jaisalmer since last fifteen months. So it is requested that his request transfer should be considered and he should be relieved from Jaisalmer to enable him to join at his transferred station.
