Sub: Pending greivences of executives.

1. Immunity from transfer to office bearers of the association.

Circle secretary had written a letter fo providing immunity from transferto our office bearers vide letter No: SNEA/ Rajasthan/Correspondence/2016-2017/27 dated 02.05.2017. circle administration issued a letter vide letter no. STA/BSNL/112-610/SNEA/2016 dated 09.05.2017 with instruction that these cases should be forwarded from SSA head. All the cases have been received from concered SSAs and put up for approval but case is still pending for want of recommendation from SSA head that has already been received as a forwarding letter containing remarks that "This letter is issued with the approval of SSA head". So it is further requested that these orders should be issued without any further delay to overcome the frustration among office bearers of recognized association.

2. Cancellation of transfer orders of Sh. N K Tak JTO from Ajmer to Bhilwara.

Mr. N K Tak JTO has been transferred from Ajmer to Bhilwara vide letter No. STA/8-15/Ch-14/R-Trf/JTO/2017/11 dated 21.04.2017 on longest stay basis. Mr. Tak is suffering from kidney disesases, his cretinin is above 4 so in this condition he can not survive alone out of Ajmer. So looking into his genuine problems his transfer order should be cancelled.

3. Cancellation of transfer order of Sh. O P Parashar JTO from Bhilwara to Sirohi.

Sh. O P Parashar has been transferred from Bhilwara to Sirohi vide letter No. STA/8-15/Ch-14/R-Trf/JTO/2017/11 dated 21.04.2017 on longest stay basis. Mr. Parashar met an accident on 07/07/2014. His uretha tube ruptured in this accident so he has to taken regular treatement on specialized hospital at Bhilwara and Ahamdabad. He can not survive at Sirohi so his transfer order should be cancellation on medical ground.

4. Change of posting station of Sh. Ravi Agrawal from Bharatpur to Tonk.

Sh. Ravi Agrawal has been transferred fromjaipur TD to Bharatpur TD vide letter No. STA/8-15/Ch-14/R-Trf/JTO/2017/11 dated 21.04.2017on longest stay basis. He has applied for change of posting station at his own cost from Bharatpur to Tonk. So please arrange to change his posting orders from Bharatpur to Tonk.

5. Consideration of request transfer under rule-8 of Mr. Sanjeev Chauhan from Rajasthan to UP (East).

Mr. Sanjeev Chauhan has completed 15 years of service, 12 years as TTA and 3 years as JTO at Jaisamler. Corporate office has issued a letter for counting the service rendered as TTS also for counting the stay period to consider the case of request transfer under rule-8 from one circle to other circle. So it is requested that his case should be forwarded to UP (East) on spouse ground. His wife is working as Govt. teacher at Sitapur (UP).

6. Change of posting station of Sh. Santosh Kumar from Alwar to Sikar.

Circle office asked choice of stations in case of longest stay transfer vide STA/8-5/stay particulars/2017-18/3 dated 24.03.2017. Sh. Santosh Kumar submitted his choice station for transfer from Jhunjhunu to Sikar. But circle office has transferred him from Jhunjhunu to Alwar vide letter No. STA/8-15/Ch-14/R-Trf/JTO/2017/11 dated 21.04.2017 on Govt. cost. So it is requested that his posting station should be changed from Alwar to Sikar on his own cost.

7. Change of posting station of Mr. Sunil Sharma from Sirohi to Udaipur to Chittorgarh.

Mr. Sunil Sharma has been transferred from Bhilwara to Sirohi vide letter No. STA/8-15/Ch-14/R-Trf/JTO/2017/11 dated 21.04.2017. Mr. Sunil Sharma has applied for change of posting station from Sirohi to Bundi or Chittorgarh due to family problem. So it is requested that his posting station should be changed from Sirohi to Udaipur to Chittorgarh.

8. Change of posting station of Mr. R S Ranawat from Sirohi to Ajmer or Chittorgarh.

Mr. R S Ranawat has been transferred from Bhilwara to Sirohi vide letter No. STA/8-15/Ch-14/R-Trf/JTO/2017/11 dated 21.04.2017. Mr. Ranawat has applied for change of posting station from Sirohi to Ajmer or Chittorgarh due to family problem. So it is requested that his posting station should be changed from Sirohi to Ajmer to Chittorgarh.

I hope that your good honour will sympathetically consider our request and do need full earliest to provide the relief to our effected executive.
