Sub: Bogus complaint of Sh. R S Yadav DS SNEA Alwar by Sh B L Meena DS AIBSNLEA Alwar.

It is stated that Mr. Devesh Sharma Organizing Secretary (North) AIBSNLEA was working as JTO (HRD/Staff) Alwar since last 7 years and Mr. S P Jain Organizing Secretary (North) AIBSNLOA is working as AGM (Admn) Alwar since last four years. Both the above mentioned office bearers of the associations were creating lot of problems for members of only recognized association SNEA in day to day office working to grab the membership by threatening and blackmailing for posting in rural areas or withholding of disciplinary /vigilance clearance for promotion.

This is necessitated for mitigating perception of possible one-unmanship by the office bearers of one association towards members of other association while holding such sensitive posts in HR, administration and vigilance section in the organization. This issue was raised time to time with the management at the corporate office level.

Then on giving due weightage to the voice of the association, after due consideration on this matter guidelines were issued for posting of office bearers of the executives' associations in sensitive posts vide memo no. 400-204/2013-pers-I dated 5<sup>th</sup> Sep. 2013 (Copy enclosed at annex-1) with clear instruction that office bearers of associations may be excluded from posting in HR/Admn/Vigilance wings.

Our DS Alwar wrote to GMTD Alwar for removing of these both the office bearers as per guidelines of Memo No. 400-204/2013-pers-I dated 5<sup>th</sup> Sep. 2013 but GMTD Alwar did not transferred them. Then I have written a letter to CGMT Rajasthan vide no. SNEA/Rajasthan/Correspondence/2016-2017/43 Dated 20.07.2017 (Copy enclosed at annex-2). Taking revenge of this correspondence for removing them from the post of JTO (Staff/HRD) and AGM (Admn), Mr. Devesh Sharma drafted bogus complaint letter against Mr. R S Yadav DS SNEA vide AIBSNLEA/ALW/GMTD/12 dated 12.07.2017 (Copy enclosed at annex-3) and threatened Mr B L Meena DS AIBSNLEA Alwar for signing this letter without reading the facts of letter. When this complaint came to notice of Mr B L Meena, then he was surprised to see this complaint letter and immediately wrote a apologising letter to CGMT (NTP) New Delhi and narrated actual facts and send this letter immediately so that image of Mr R S Yadav may not got tarnish (Copy enclosed at annex-4).

Mr. R S Yadav is completing his tenure of DS on 31/03/2018. So it is requested that your good honour will look into this whole matter thoroughly and act judicially to get discourage these unsocial elements.

I hope that justice will prevail under dynamic leadership of officer like you.
