Sub.: Regarding grievances of members

1. Retention of Mr. Shekhar Gaur, JTO Jaipur :

Mr. Shekhar Gaur is under is under transfer from Circle office Jaipur to Ajmer vide letter No. STA/8-15/ch-12/R-Trf/JTO 2015/6 dated 08-04-2015 on longest stay basis and he has been relieved from CO Jaipur vide letter No. STA/7-12/JTO/65 Dated 30-07-2016.

Mr. Shekhar Gaur is divorced person and living with his 80 years old mother. His mother is suffering with chronic remehtied Arthritics and diffusion of bones disease. She is critically ill and recently admitted in hospital. Mr. Shekhar is not in a position to shift her at Ajmer and leaving alone at Jaipur. So it is requested that Mr. Shekhar Gaur should be returned at Jaipur till 31-03-2017, so that he can attend her mother at Jaipur till recovering her health.

2. Request of Mr. R.K. Jain, TDM for posting at Kota :

Mr. R.K. Jain was working at looking after JAG since last two years as DGM (Admn) Kota. Mr. R.K. Jain was promoted as Adhoc DGM Vide STA/8-11/STS to DGM(T)/adhoc/2016-17/11 dated 02-04-2016 and posted as TDM Jhalawar. He has joined his duty on 15/04/2016 as TDM Jhalawar. Mr. Jain is going to retire on Superannuation on 31st March 2017. recently Mr. Subhash Agarwal and Mr. J.P. Meena were relieved on their transfer from Rajasthan Circle to other circle on longest stay basis and Sh. Govind Singal has been assigned the charge of GM (Kota) on standalone basis and he has taken the charge of GMTD Kota. So instead of for only one DGM Sh. S.N. Gupta is left working at Kota. So Mr. R.K. Jain should be posted at Kota or giving additional charge of DGM Kota. It is requested that request of Mr. R.K. Jain should be considered to post him at Kota.

3. Request transfer case of Mr. Jeele Singh JTO from Sikar to Jaipur on ground of disabled child:

Mr. Jeele Singh has been promoted from TTA to JTO on 31.03.2014 and posted at Sikar. He is working at Sikar since 29.03.2014. His 18 years old son is suffering from cerebral palsy and disabled above 40% (circular with medical certificate attached) as per letter No. 6-1/2007- Restg Col-III dtd.24th Nov.2014 amendment in BSNL employees transfer policy, employee who is care giver of disabled child may be exempted from transfer and preference in place of posting at the time of transfer/promotion may be given. Mr. Jeele Singh has completed more than two years stay at Sikar and his name has been registered in the request register at serial no. 54. So his request should be considered to provide relief to his family on medical ground.

4. Request transfer of Mr. Samarth Lal Meena, SDE from Swaimadhapur to Jaipur:

Our District president of SNEA Swaimadhapur branch has registered his request for request transfer from Swaimadhapur to Jaipur. This request has not been considered so far, by Circle administration. So it is requested that his request for transfer to Jaipur should be considered immediately.

5. Request transfer of Mr. Kapil Saini JTO, from Sikar to Jaipur:

Mr. Kapil Saini, JTO Sikar, our Area Secretary (North) has registered his own cost request in request register before three years but his request has not been considered by Circle administration till date. So it is requested that his request for transfer to Jaipur should be considered immediately.

I hope your honour will personally look in to these issues and settle them earliest to provide the relief to our members.
