Sub :- Acute Shortage of essential stores and grievances of members.

- 1. Acute shortage of essential store :-** Since last three months EPBT Telephone instruments are not available at Rajasthan Circle. Due to acute shortage of EPBT instruments NTC work is affecting badly,UG cable Joint closers of No2 and 3 are also running short since long. So maintenance work is also badly affecting. An essential meter i.e. power meters for maintenance and installation work of transmission network are also running short since long. Drop wire is also running short since last one year so due to shortage of these essential stores development and maintenance work of telephone network is adversely affecting it is requested that these essential stores for development and maintenance work should be arranged immediately by diversion from other circle or by procurement through open market or telecom factory so that outdoor network may not suffer any more.
- 2. Request of Mr. R.K. Jain, TDM for posting at Kota :-** Mr. R.K. Jain was working as looking after JAG since last two years as DGM (Admn) Kota. Mr. R.K. Jain was promoted as Adhoc DGM Vide STA/8-11/STS to DGM(T)/adhoc/2016-17/11 dated 02-04-2016 and posted as TDM Jhalawar. He has joined his duty on 15/04/2016 as TDM Jhalawar. Mr. Jain is going to retire on Superannuation on 31st March 2017. recently Mr. Subhash Agarwal and Mr. J.P. Meena were relieved on their transfer from Rajasthan Circle to other circle on longest stay basis and Sh. Govind Singal has been assigned the charge of GM (Kota) on standalone basis and he has taken the charge of GMTD Kota. So instead of for only four DGMs Sh. S.N. Gupta is left working at Kota. So Mr. R.K. Jain should be posted at Kota or giving additional charge of DGM Kota. During informal meeting on 7th Nov. 2016 your good honour has agreed for considering the request of Mr. R.K.Jain for transferring him from Jhalawar to Kota and advised that a fresh request appreciation has to be asked from Mr. Jain with mentioning of his fact that Mr. Jain is permanent resident of Kota the same has been taken and submitted to admin cell of circle office but the request had been turn down on the fictitious ground of no merit in the cases even after agreed by CGMT. It is requested that request of Mr. R.K. Jain should be considered to post him at Kota.
- 3. Change of Posting Station of Mr. H. R. Bhati looking after as AGM from Barmer to Jodhpur :-** Mr. H.R. Bhati was working as looking after AGM at Jodhpur since last one year but recently reviewed looking after arrangement orders Vide STA 8-11/GA/LA/2016-17/86 dt. 26.11.16 he has been posted at Barmer for looking after as AGM for considering the request transfer of Mr. M.K. meena regular AGM from Pali to Jodhpur in mid session without completing his stay of

three years at Pali. As per executives transfer policy all the request has to be considered in the month of April every year computing period of stay up to 31st March.

Mr. A.K. Tiwari regular AGM has been relieved on 7th Dec. 2016 from Jodhpur to join at J&K on longest stay transfer from corporate office. Mr. Nakta Ram AGM (Admin) Jodhpur is also going to retire on superannuation on 31st Dec. 2016, so due to this situation two posts of AGM are running vacant at jodhpur Mr. H.R. Bhati is president of our Jodhpur Branch. So his posting order should be revised from Barment to Jodhpur earliest to enable him to join at Jodhpur.

Mr. N.K. Choudhary working as looking after AGM at Jodhpur is willing to go to Barmer at his own cost so his request has to be considered to post him at Barmer as looking after AGM so work of Barmer SSA can also run smoothly.

4. **Cancellation of transfer order of Mr. N.K.Jain from Kota to Jaipur :-** Mr. N.K. Jain JTO CMTS, Kota has been transferred from Kota to Jaipur vide memo no. STA/8-15/ch-13/R-Trf/JTO/2016/39 dated 08-12-2016 as substitute in place of Sh. A.K.Dewivedi SDE he is under transfer to MP Circle, Sh. N.K. Jain has been transferred from Jhalawar to Kota on his own cost request just before four years Mr. Tarun sainin JTO Sikar has registered his own cost request for transfer to CMTS Wing Jainpur. So request of Mr. Tarun Saini should be considered for post him as substitute of Mr. A.K. Diwedi SDE on his transfer to MP Circle and transfer order of Mr. N.K. Jain should be cancelled immediately.
5. **Change of Posting station of Mr. B.M.Sharma from Sirohi to Sikar :-** Mr. B.M. Sharma SDE has been transferred Vide memo No. STA/18-15/GB/Rotational trf/2015-16/15 dated 31.03.2016 from CMTS Wing Jaipur to Sirohi on longest stay basis and relieved vide memo no. CMTS /10-102/Staff/Grant/2015-16/144 dated 20.07.2016. Mr. Sharma is suffering from serious heart problem, he has under gone to major hart surgery and continuously under observation and regular treatment at Jaipur. So he has requested for change of posting station on transfer from Sirohi to Sikar so tht he can also take care of his health being adjoining to Jaipur while serving to company. On the 7th Nov. 2016 during internal meeting your good self has agreed to change the place of posting Sikar instead of Sirohi and marked the application for put up but nothing has been done till date this is a clare cut ignorance of orders of higher officers at lower level.
6. **Releiving of Mr. H.R. Meena for looking after as AGM from Bhilwara to Jhalawar :-** Jhalawar SSA is running without any AGM since last near about one year. TDM Jhalawar was pressing hard for posting of any AGM at Jhalawar. I personally search Mr. H.R. Meena at Bhilwara who can go to Jhalawar as AGM look after and suggested GM (HR) for post him at Jhalawar as L/A AGM, so this post can be filled up, accordingly Mr. H.R. Meena has been posted at Jhalawar as L/A AGM. But he has not been relieved till today from Bhilwara. So it is requested that Mr. H.R. Meena should be relieved from Bhilwara immediately so that he can join his duty at Jhalawar as Looking After AGM.

I hope your honour will personally look in to these issues and settle them earliest to provide the relief to our members.
